Tenders/bids shall be accepted only through online mode on the e-GP website and no manual submission on the same shall be entertained. Late tenders will not be accepted. document. The offers shall be opened online at GCDA on 25.11.2020, 11.00 am by Superintending Engineer in the presence of bidders or their representatives who wish to attend at the above address.

If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place.




